Prior to joining the firm in 1999, Mr Velevis was employed as a stockbroker by a national brokerage company.

Mr Velevis earned the designation of Certified Financial Planner CFP® in May 2003, following a two-year study program providing instruction for comprehensive financial planning for individuals. The CFP® designation also requires an examination and three years of practical experience in personal financial planning. CFP's are required to complete continuing education on a yearly basis, and they must renew an ethics agreement annually vowing to practice financial planning on a fiduciary basis.

Mr Velevis has been a member of the National Association of Personal Financial Advisors (NAPFA) since 2003. As an organization, NAPFA promotes fiduciary, comprehensive financial planning, which it believes must be conducted on a fee-only basis to prevent conflicts of interest that characterize relationships compensating advisers with third-party incentives or commissions. NAPFA members are compensated only by their clients; they do not receive commissions or other remuneration from the investments they recommend for their clients.

In a natural succession process, Mr Velevis became the managing principal and owner of H.S. Dreher Capital Management, LLC in September 2010.

### **Item 3: Disciplinary Information**
